No quorum shall be required for the election of the Broad of Directors provided votes are cast by ten percent (10%) of the Members. The presence (in person, by proxy or by absentee ballot) of Members entitled to cast one-tenth of the votes shall constitute a quorum for any other action, except any action requiring the consent of a greater number of Members as provided in the Articles of Incorporation. The Declaration or these Bylaws. A quorum at members meetings shall consist of persons present in person, by proxy or by absentee ballot entitled to cast ten percent (10%) of the votes of the entire Membership. The acts approved by a majority of the votes present at a meeting at which a quorum is present shall constitute the acts of the Members, except when approval by a greater number of the Members is required by the Declaration, the Articles of Incorporation or these Bylaws.
